

House Bill 3, 86th Legislature Science of Teaching Reading Exam Mandate



To earn a certificate to teach Pre-K to grade 6, a candidate must demonstrate proficiency in the science of teaching reading on a new, standalone certification examination, starting January 1, 2021.




TEC Sec 21.048 (a-2): The State Board for Educator Certification "shall adopt rules that provide that in order to teach any grade level from prekindergarten through grade six a person must demonstrate proficiency in the science of teaching reading on a certification for each class of certificate issued by the board after January 1, 2021."



Registration for 293 Science of Teaching Reading TEXES is now open.

Scores for this exam are reported within 28 days of testing. The earliest date that you could receive your score report is noted in the following schedule. Score reports are posted to candidate accounts at 10:00 p.m. Central time on these dates.



TEM Critical information for these candidates

December Finishers

I will have finished my educator preparation program by December 2020 and received my standard teaching certificate. Am I impacted?

No. Teacher candidates who have finished their educator preparation program AND have been issued their standard certification prior to December 31, 2020 will not be required to take the STR certification exam.

> If the teacher candidate's standard certificate has not been issued before December 31, 2020, the teacher candidate WILL be required to take the STR exam for issuance of their standard certificate.

How do I ensure that my standard certificate is issued prior to December 31, 2020?

Teacher candidates who complete educator preparation programs in Fall 2020 will need to take the following steps to ensure that their standard certificate is issued before the December 31, 2020 deadline:

- · Pass all required certification exams
- Complete fingerprinting
- Pay all certification fees
- · Apply for their standard certificate, and
- Obtain a recommendation from their EPP for a standard certification in ECOS*

*Note: Teacher candidates should actively communicate with their EPP to notify them that they have applied for their standard certification to ensure that they obtain the necessary EPP recommendation.

> As soon as a standard certification has been issued, it will be visible on a teacher's SBEC Virtual Certificate at the link below:

Waiver Probationary Cert Holders

I completed my educator preparation program in Spring/Summer 2020 and got a one-year probationary certificate instead of my standard because of COVID-19. Does the STR exam requirement impact me?

It will, unless you act before December 31. Teachers on a one-year probationary certificate who have completed all certification exam requirements and been issued a standard teaching certificate prior to December 31, 2020 will not be required to take the STR certification exam. While the one-year probationary certificate is valid up to one year after issuance, teachers on the one-year probationary certificate are strongly encouraged to complete all steps for standard certification issuance prior to December 31, 2020, in order to not be required to take the STR exam.

> If the one-year probationary certificate holder has not been issued a standard certificate before December 31, 2020, they WILL be required to take the STR exam for issuance of their standard certificate.

How do I ensure that my standard certificate is issued prior to December 31, 2020?

Teachers on a one-year probationary certificate under the Governor's waiver will need to take the following steps, in collaboration with their educator preparation program, to ensure that their standard certificate is issued before the December 31, 2020 deadline:

- Pass all required certification exams.
- · Apply for standard certification
- · Pay all certification fees, and
- . Obtain a recommendation from their EPP for a standard certification in ECOS*

*Note: Teachers should actively communicate with their EPP to notify them that they have applied for their standard certification to ensure that they obtain the necessary EPP recommendation.





Candidates will be required to take the 291 Core Subjects: EC-6 TEXES or the 391 Core Subjects: EC-6 TEXES, the 293 STR TEXES, and the 160 PPR TEXES or the edTPA for standard certification.

STR Exam Structure after January 1, 2021

By statutory mandate, the STR exam is required for the certificate to <u>ISSUE</u>, beginning Jan. 1, 2021

Beginning 1/1/2021, all candidates will be required to take the STR exam for issuance of an intern, probationary, and standard certificate. This includes:

- Currently enrolled candidates pursuing certification in an HB3 impacted certification field who are not issued a standard certificate by 12/31/20.
- Future candidates pursuing certification in an HB3 impacted certification field
- Candidates who may have previously completed a preparation program who have not been issued a standard certificate by 12/31/20.
- Candidates <u>issued the Waiver Probationary Certificate</u> who have not completed all testing requirements and have not been issued a standard certificate by 12/31/20.
- Teachers seeking certification by exam for an HB3 impacted certificate field after 1/1/21.

Date	Relevant Action
March 2018	Science of Teaching Reading Standards are adopted by the SBEC.
June 2019	House Bill 3, 86 th Legislature, requires that all educators who teach students in grades PK-6 demonstrate proficiency on a science of teaching reading certification exam beginning Jan. 1, 2021.
November 2019	STR Test Framework is available after stakeholder review, public comment period, and content validation processes.
November 2019 – February 2020	Language Essentials for Teachers of Reading and Spelling (LETRS) training offered free of charge to all educator preparation programs to inform the development of STR-aligned curriculum.
February - July 2020	SBEC adopted updates that would organize the STR Standards to ensure clarity that they apply to candidates who teach students in grades PK-6.
September 2020	STR Preparation Manual available.
November 2020	Reading Academy training offered free of charge to educator preparation programs to support the alignment of pre-service and in-service teacher STR development.
January 1, 2021	Assessment launch

Required Action: STR Letter of Attestation

- EPPs are required to indicate their ability and readiness to successfully
 prepare candidates for certification in the HB3 impacted certification fields
 through the STR Exam Letter of Attestation.
- The Letter of Attestation must be signed by the program's legal authority indicating the program's intent to modify its curriculum by January 1, 2021
- Deadline: December 1, 2020
- If programs do not submit the Letter of Attestation by the deadline, they
 have indicated that they choose not to prepare candidates in these fields and will
 be removed from the ability to certify candidates in these areas.

House Bill 3, 86th Legislature Science of Teaching Reading Exam Mandate



To earn a certificate to teach Pre-K to grade 6, a candidate must demonstrate proficiency in the science of teaching reading on a new, standalone certification examination, starting January 1, 2021.

House Bill 3, 86th Legislature Texas Reading Academies HB 3 Mandate



HB3 amend statute to include multiple reading initiatives:

- Requires all Kindergarten through third-grade teachers and principals must begin the Texas Reading Academies training before the 2022-2023 school year
- Requires districts and charters to provide phonics curriculum using systematic direct instruction in grades K-3
- Requires districts to certify to the TEA that the district:
 - Prioritizes placing highly-effective teachers in K-2 and
 - Has integrated reading instruments to support Pre-K to grade 3 students

Frequently Asked Questions about Reading Academies and the STR Exam

What is the difference between the STR exam requirement and the Reading Academies requirement?

- Although the STR examination and the Reading Academies are both requirements of HB 3 from the 86th Legislature, 2019, they are different mandates.
- The STR examination is a mandated requirement for the <u>issuance of a Teaching Certification</u>. The STR examination is required for teacher candidates seeking certification in the following certification fields:
 - Early Childhood: EC Grade 3
 - Core Subjects with Science of Teaching Reading: Early Childhood–Grade 6
 - Core Subjects with Science of Teaching Reading: Grades 4–8
 - English Language Arts and Reading with Science of Teaching Reading: Grades 4–8
 - English Language Arts and Reading/Social Studies with Science of Teaching Reading: Grades 4–8
- Completion of the Reading Academies is a mandated requirement for all in-service teachers and administrators who teach students in grades Kindergarten to 3rd.
- Teachers who take and pass the STR exam will <u>still be required</u> to take the Reading Academies once hired by a Texas LEA.



Frequently Asked Questions about Reading Academies and the STR Exam

If a candidate passes the STR exam, are they required to take Reading Academies?

Yes, the STR exam and Reading Academies are separate requirements.

If an intern teacher participates in and completes the Reading Academies training, are they required to take the STR exam?

Yes, all teacher candidates seeking certification in an HB3-impacted field will be required to take and pass the STR exam for issuance of an intern, probationary, or standard certificate after 1/1/21.

Development of 391:

- Updated ELAR subtest to remove duplicative content
- Reduction and redistribution of content across remaining subtests, increasing available time per item

Transition Period:

- Both exams will be operational from Jan 1, 2021 Dec. 31, 2021 (one-year overlap)
- Recommended that first-time test takers take 391 after Jan. 1, 2021
- Yearlong overlap in operational periods to support candidates who are still needing to pass specific 291 subtests

Certification Issuance:

• A passing score on 291 can be used for issuance of the Core Subjects with STR: EC-6 no later than Dec. 31, 2022.

- No change to exam framework or exam test design
- Updated Representative Exam available for replacement (late Oct.)
